1. Avneesh Arputham, Advocate on Record

Avneesh is an Advocate on Record in the Supreme Court of India representing clients in a wide range of International Dispute Resolution, Commercial Litigation and White Collar Crime. He graduated in BA (Honours) Economics from St. Stephen's College, India and completed his LLB from University of Delhi in 2010. Subsequently, he pursued his LLM in International Commercial Law at the London School of Economics (LSE), for which he was awarded the Merchant Foundation Scholarship. While pursuing his LLM at the LSE, he worked with the House of Commons, UK Parliament. Thereafter, he pursued his second LLM from the University

College Dublin (UCD) and Universit at Pompeu Fabra, Barcelona in European Law and Public Affairs, for which he was awarded the fully funded Erasmus Mundus Scholarship. He was the Convenor of the Moot Court Society in Campus Law Centre, University of Delhi and has won many national and international moot court competitions. He also has the distinction of being a judge in many international moot court competitions such as the Price Monroe International Moot Court Competition held at the University of Oxford and the Stetson International Environmental Law Moot Court Competition.

2. Prateek Lakra, Advocate

Prateek completed his LLB from Amity University, Delhi and is presently pursuing his LLM at the United Nations Interregional Crime and Justice Research Institute, Italy. He has won the UPES National Trial Advocacy Competition and was Runners Up in the Amity Intra Trial Advocacy Competition and the UPES International Judgement Writing Competition.

DETAILS OF THE WORKSHOP

Dates: 1st to 3rd May 2020. Time: 5-6 PM.

Venue: Online/Video Conference

The workshop will be conducted over three days with a one hour session daily. Participants will be given training in how to read and understand moot problems, carry out research, draft memorials and develop arguing/presentation skills. The workshop will follow a Socratic Case Study Method where a hypothetical Moot Problem will be shared with the participants at the time of registration. All participants are required to read this moot problem thoroughly for the first class and identify the factual and legal issues. After the end of the first class, a sample memorial will be

shared for the second and third class, and through this case study, the participants will be given invaluable knowledge of mooting. At the end of each session, participants are encouraged to ask questions to ensure greater clarity of learning. The questions can also be sent via email after the session.

The workshop will be conducted online via video conferencing as per the details provided to the registered participants through email.
